not adversely impact department budget timelines or the renewal of associated
contracts.

- A motion was made by DA Dudley and seconded by Ray McDonald to approve an expansion request for 1.0 of additional Masters Level Social Worker (MSW) staff in the Office of the Public Defender increasing the FY 2020-21 Public Safety Realignment Plan expenditures by \$100,937 to a total of \$14,705,414.

- 6. Proposed Allocation of Public Safety Realignment Fund Balance for FY 2020-2021 Realignment budget – Kimberly Shean
  - A PowerPoint was provided and reviewed with the group.
  - PD Macuga asked about the impact of the early release of individuals from prison and their housing needs.

- Chief Heitman stated California Department of Corrections and Rehabilitation (CDCR) is implementing up to 60 day early releases for individuals that are non-sex offenders, nonviolent, and non-domestic violence on parole or Post Release Community Supervision (PRCS). Probation is anticipating 16 PRCS individuals beginning on April 7<sup>th</sup>. Probation is reviewing who is being released to ensure they have housing and services due to the COVID-19 crisis.
- A motion was made by Dr. Salcido and seconded by PD Macuga to extend the Supportive Housing Pilot program end date by two (2) months to coincide with the end of the fiscal year increasing the FY 2020-21 use of Programmatic Restricted Fund Balance by \$66,667.

- Chief Heitman stated this will be a presentation of the full plan including the fiscal items approved today and at the February meeting. She thanked the workgroup members for all the work done to develop the plan.
- The FY 2020-21 Plan was developed prior to the COVID-19 crisis and information will be added advising of changes that are happening and will continue to take place as this situation evolves.
- Individuals that are being released early will not have extended supervision time, they are just starting earlier. Programming and other services are being transitioned to electronic when feasible and Probation continues to review how individuals are supervised going forward. This may result in a need to change areas included in the plan going forward.

- DCPO Shean thanked Probation Manager Spencer Cross, Project Manager Karyn Milligan and all the workgroup members for their work to develop the FY 2020-21 Realignment Plan.
