# 10. California Community Corrections Performance Incentive Act of 2009 (Senate Bill 678) Update and FY 2021-22 Plan – Research Manager Karyn Milligan and Deputy Chief Kimberly Shean

 A memo was provided and reviewed with the group to update them regarding local use of the California Community Corrections Performance Incentive Act of 2009 (SB 678) funding.

# **11. Sheriff Jail Data Analysis** – Research Manager Karyn Milligan

- A presentation and analysis was shared with the group regarding Jail Data during the COVID-19 pandemic based on individuals provided by SBSO.
- Sheriff Brown advised that the limited individuals released were due to zero bail and the
  plan was to track this original group. He advised that one third of the individuals have
  been re-booked and some of them multiple times. The analysis shows that those
  released on zero bail were not new to the SBSO and many had been booked previously
  on prior charges. Chief Heitman advised of the importance to look at individuals that are
  recidivating prior to and after the pandemic to correlate recidivism to zero bail.
- Supervisor Hart stated data needed to be fully vetted at the Workgroup so what is brought forward to the CCP is a full picture.
- PD Macuga indicated that this is a small sample and as a Public Defender she wants information regarding their housing stability, discharge plan, connection to BW, and substance abuse issues. As many individuals are on Probation Supervision or being released on Pretrial are successful, we should also be highlighting successes.
- Dr. Gleghorn stated that during Zero Bail the BW substance abuse assistance line was able to screen individuals and have them go to the sobering center and connect them to substance abuse treatment. There will be additional funding coming to the County to target those that were incarcerated during COVID-19 for discharge planning, transportation from jail to treatment centers, and a mental health navigator.
- Sheriff indicated individuals are reoffending, nothing is happening with the courts being closed and they are out on Zero Bail. We need to determine how to hold repeat offenders accountable.
- Sylvia Barnard reported to the group that many of the homeless shelters were closed and it was a big factor during COVID-19.

 Chief Heitman reminded the group that the CCP Workgroup has a developed a subcommittee to review this and anyone is interested in participating please advise DCPO Kimberly Shean.

# 11. Relative Rate Index (RRI) – Research Manager Karyn Milligan

- A presentation was provided on the RRI of justice-involved clients at different decision points within our local justice system.
- The membership thanked Karyn Milligan for the presentation as the data is helpful to help address any issues of disparity.
- Ethan Bertrand advised the racial and ethnic disparity workgroup has met and this information will be very useful as different diversion points in the system are reviewed.

### 12. Criminal Justice Funding Opportunity Submissions Update

- Prison to Employment Update Ray McDonald
  - The program is operational and work is underway with Probation and Goodwill Industries.
  - This program will serve 38 individuals through June 2022. There are currently 10 individuals being served by the program.
  - There is a Federal Grant opportunity to assist individuals while they are incarcerated and continues to serve them once released. An application in coordination with the SBSO has been submitted for \$2.5 million over several years.
  - There is also a similar grant that serves youth and talks are underway with Probation to determine how to approach as it requires a Community Based Organization as the lead.
