- 1. "Results First" Presentation Ashleigh Holand, Pew-MacArthur Results First Initiative, Amalia Mejia, California State Association of Counties (CSAC), & Karyn Milligan, Probation Department
 - Ashleigh, Amalia, and Karyn provided an overview of Results First in Santa Barbara County and other counties participating as well as options for utilizing the Result First model for the juvenile population.
 - A Results First convening hosted in Santa Barbara for all California participating counties will be held on October 25th and 26th. On October 24th there will be a workshop to look at how the principles of Results First could be applied to county budgeting and contracting processes, Department's budget analysis and Chief Fiscal Officers are encouraged to attend.

Comments from CCP members not on Agenda

- Supervisor Wolf asked for a briefing on Stepping Up at the next CCP meeting.
- Darrel asked about the funding that was added to the PD's Office to review individuals that could be eligible for resentencing as this is something that affects the DA and Courts. Tanja advised the PD's Office was given the first piece of funding to do data and case mining to determine the magnitude of those eligible. PD Macuga hired an extra help staff to conduct data mining and believes this will be a relatively quick process. This will help us know how many individuals will be eligible but we won't know how many will apply. Tanja informed the group that once the information is available it will need to be presented to the CCP workgroup, then CCP and then the Board of Supervisor to allocate

funding to the DA and Court's in response to this effort. This is reserved funding so it does not need to be on the traditional budget planning timeline.

Chief Probation Officer Comments – Chief Taylor

- Chief Taylor welcomed the new Superintendent of the Santa Barbara County Education Office (SBCEO) Susan Salcido to the CCP.
- Tanja provided a briefing on the Stepping Up Initiative, Mental Health Rehabilitation Center (MHRC) feasibility study process, Pre-Trial Services, Data Committee, Sheriff's Treatment Program (STP), and the Re-Entry and Community Engagement process. These items will be on the October CCP meeting agenda for a more comprehensive review.

 - A handout was provided and reviewed with the group.
