- I. Call to Order and Introductions Deputy Chief Probation Officer (DCPO) Kimberly Shean

## II. **Approval of Minutes** – All

• A motion was made by Angela Braun to approve the draft minutes of the December 19, 2018, Community Corrections Partnership Realignment Planning Workgroup (CCP Workgroup) meeting, as submitted. The motion was seconded, and the minutes were approved.

#### III. Public Comment – All

• Maureen Earls provided a public comment regarding housing.

### IV. **Comments from the Chair**– DCPO Kimberly Shean

• Reminder was provided that a second meeting in the month of January would be held on January 23<sup>rd</sup>. At that meeting there will be a review of the housing recommendation based on the request for proposals (RFP) received.

## V. Fiscal Year (FY) 2019-2020 Realignment Budget for Submission to the Community Corrections Partnership (CCP) – DCPO Kimberly Shean

- DCPO Shean advised if there is a conflict it should be recognized in advance and discussion by those with conflicts should be limited with the exception of answering of program related questions.
- DCPO Shean informed the group that there are several handouts including a rollover budget, expansion requests, and a one-time allocation that were reviewed and discussed with the group. The plan was to have individual votes for each of the budgets.
- Deepak Budwani advised that the information provided on the expansion request for the Public Defender's (PD) Office is actually bringing the funding for the Legal Office Professionals (LOP) to the accurate funding level as the funding is \$103,000 short. The group discussed how to manage the request either updating the budget on the rollover budget or continuing on the expansion request. A request was made to get clarification as to how this request was originally made to best inform where the update needs to be made. Probation and the PD Office will research and provide additional information to get clarification as to when the request was originally made as to amount and extra-help or a for fulltime employee.
- The group reviewed and discussed the expansion requests handout, providing clarifications, updates and deletions ultimately modifying the amount requested.
- Bernard Melekian stated that the County Executive Officer policy for the County's budget is if an expansion requests is funded, a reduction needs to be made. He believe that is the principle that should be followed and not continue to utilize reserve funding for ongoing programs.
- Ten percent of Realignment growth funding goes to the County to be allocated by the Board of Supervisors (BOS), there is approximately \$300,000 in the fund.
- DCPO Shean advised that the plan was to have three votes one on the rollover budget, one on the expansion, and one on the one-time budget. It appears we need additional information

- about the PD LOP funding which has resulted in none of the budgets being able to be approved. If the budgets presented are approved it would requires over \$1 million in reserve fund, resulting in the reserve account balance being under \$3 million.
- Bernard Melekian suggested Probation and SBSO meet to review funding as the bulk of the budget is within these two Departments.
- It was decided that the group needs additional information to move the budgets to the CCP. As such additional information will be brought back to the January 23<sup>rd</sup> CCP Workgroup meeting regarding clarification on the PD Office LOP positions and how they were requested to be funded, a minimum of a two year review of the SBSO alternative sentencing program, and a review of the Compliance Response Teams (CRTs) activities.
- The updated budget sheets will be shared with the membership to allow for analysis by each Department.

## VI. **Public Safety Realignment Evaluation Update** – Karyn Milligan

• Karyn provided a review of the memo advising the workgroup that the Realignment evaluations will be presented at the February CCP meeting.
