I. Call to Order and Introductions – Deputy Chief Probation Officer Kimberly Shean

- The meeting was called to order at 9:02 a.m.
- Attendees provided self-introductions.

II. **Approval of Minutes** – All

- A motion was made by Mary O’Gorman to approve the draft minutes of the May 23, 2018, Community Corrections Partnership Realignment Planning Workgroup (CCP Workgroup) meeting, as submitted. The motion was seconded, and the minutes were approved.

IV. **Comments from the Chair** –Deputy Chief Probation Officer (DCPO) Kimberly Shean

- The Probation Department has selected Health Management Associates (HMA) to complete the realignment evaluations. Probation is working on developing the contract and the first report completed by HMA will be the 2018 outcome evaluation which will be presented in 2019. This will be added to the August agenda for further update.

V. **Housing Subcommittee** – Deputy Chief Probation Officer Kimberly Shean

- The first official housing subcommittee meeting met in May immediately after the CCP Workgroup meeting.
- Those present reviewed the population and the variety of housing options that are available throughout the County.
- The Chief and DCPO Shean met with the Community Services Department (CSD) and determined that CSD staff will attend future housing subcommittee meetings to help move the pilot forward.
- The housing subcommittee meeting will meet today at 11AM.

VI. **Criminal Justice Funding Opportunity Submissions** – DCPO Kimberly Shean

- Dr. Gleghorn provided a California State Association of Counties (CSAC) budget summary which was forwarded to the group and discussed. The State funding allocations and guidelines continue to change.
- Chief Custody Deputy Wasilewski provided a funding opportunity submission for a medication assistant treatment (MAT) program. This grant is for \$25,000 to build a team, provide training, and to put together a comprehensive MAT program. Dr. Gleghorn advised that the Sheriff’s Office will need to offer two additional medications in the jail and the methadone discuss has been tabled. The grant also indicates if the County has a jail and a drug court it appears both populations must be included. Dr. Gleghorn indicated she believes that the intent was for courts to broaden their recommendations and expand the tool kit for people with opiate use disorders. Mary O’Gorman motioned to approve the submission, Dr. Gleghorn seconded, and all approved with Angela Braun abstaining.
- Ray McDonald advised that the Governors Prison to Employment Initiative is region wide which includes Santa Cruz, San Luis Obispo, and Santa Barbara counties. An informational meeting was held that Karyn Milligan and Jessica McLernon attended. There is \$37 million over three years across the State to integrate workforce and reentry services. This funding can be used for anyone that is justice involved. This item will be added to the CCP workgroup agenda to continue to provide updates.
