7. **Commercial Sexual Exploitation of Children (CSEC) Presentation** – Dana Roscoe  
Commercial Sexual Exploitation of Children (CSEC) involves the sexual exploitation of minors for economic profit. Due to recent legislative changes, these children and youth now generally are under the jurisdiction of the child welfare system. Provide an overview of the county's multi-agency efforts to identify and assist youth in Santa Barbara County who have been commercially sexually exploited, or who are at risk of exploitation.

8. **Title 15 changes for Institutions** – Shawn Small  
In 2018, the Board of State and Community Correction (BSCC) enacted a major revision to the California Code of Regulations, Title 15, Division I, Chapter 1, Subchapter 5 (Minimum Standards for Juvenile Facilities), Article 1, *et seq.* These changes will go into effect January 1, 2019. The presentation will broadly address the scope and nature of the changes and identify in greater detail those major elements impacting local operations at Santa Maria Juvenile Hall and Los Prietos Boys Camp.
