- 6. Positive Achievement Change Tool (PACT) Karyn Milligan Probation has selected the PACT as the Department's new risk/needs assessment for juveniles. This presentation will provide a brief overview of the tool, as well as the concepts of criminogenic needs and risk-needs responsivity. Information only
- 7. Continuum of Care Reform (CCR) Implementation Progress Holly Benton Assembly Bill (AB) 403, the Continuum of Care Reform Act (CCR), was passed into law in October 2015 and took effect January 1, 2017. This legislation enacted sweeping changes to child welfare and probation placement processes. Presentation will provide an overview of the changes, as well as impacts for Santa Barbara County probation youth and overall placement trends.

8. Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) Update – Holly Benton Assembly Bill (AB) 1913, the Schiff-Cardenas Crime Prevention Act of 2000 (Chapter 353), created the Juvenile Justice Crime Prevention Act (JJCPA) program. The JJCPA provides a stable funding source for local juvenile justice programs aimed at curbing crime and delinquency among at-risk youth. Counties are required to complete and annually update a Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) describing objectives and strategies for working with this population.
