
7. Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) for Fiscal Year (FY) 2019-2020 – Holly Benton

Assembly Bill 1998 went into effect on January 1, 2017 and made important changes to the planning and reporting requirements under the Juvenile Justice Crime Prevention Act (JJCPA) and the Youthful Offender Block Grant (YOBG) programs. Most significantly, many of the requirements are now combined for the two programs. The CMJJP has been updated to meet the new requirements and serves as a consolidated JJCPA/YOBG Plan. a. 8. Diversion Services and Alternative Sanctions for Youth on Probation – Holly Benton As part of the ongoing analysis of juvenile services, the Probation Department has determined there is a need for additional diversion services for youth referred to Probation, as well as alternative sanctions provided to youth on probation to address specific treatment needs.

9. Youth Reinvestment Grant (YRG) – Holly Benton

The YRG program was established in the 2018 Budget Act (Senate Bill 840, Chapter 29, Statutes of 2018) and its related trailer bill (Assembly Bill 1812, Chapter 36, Statutes of 2018). The YRG program is focused on diverting low-level offenders from initial contact with the juvenile justice system using approaches that are evidence-based, culturally relevant, trauma-informed, and developmentally appropriate. Grant funds will be used to target underserved communities with high rates of juvenile arrests and high rates of racial/ethnic disproportionality within those juvenile arrests. Community-based organizations that receive these funds must provide diversion and alternative-sanction programs, academic- and vocational-education services, mentoring, behavioral health services, and mental health services.

10. Reimagining Juvenile Justice (RJJ) Curriculum – Tanja Heitman

The Annie E. Casey Foundation (AECF) is sponsoring an innovative staff development initiative created for professionals working with justice-involved youth and their families. This curriculum builds capacity for a multi-agency cohort to support, divert and redirect youth to appropriate and fair justice options, including options that require a high degree of cross-system collaboration and coordination.
