## IMPORTANT NOTICE REGARDING PUBLIC PARTICIPATION

Based on guidance from the California Department of Public Health and the California Governor's Stay at Home Executive Order N-33-20 issued on March 19, 2020 to protect the health and well-being of all Californian's and to establish consistency across the state in order to slow the spread of COVID-19, the Juvenile Justice Coordinating Council (JJCC) meeting will not provide in-person participation.

## 4. Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) for Fiscal Year (FY) 2021-22 – DCPO Holly Benton

Assembly Bill 1998 went into effect on January 1, 2017 and made important changes to the planning and reporting requirements under the Juvenile Justice Crime Prevention Act (JJCPA) and the Youthful Offender Block Grant (YOBG) programs. Most significantly, many of the requirements are now combined for the two programs. The CMJJP has been updated to meet the new requirements and serves as a consolidated JJCPA/YOBG Plan.

- 7. FY 2021-22 Juvenile Justice Realignment Plan (JJRP) DCPO Holly Benton Senate Bill (SB) 823, passed by the California State Legislature on August 31, 2020 and enrolled September 4, 2020, created the Office of Youth and Community Restoration (OYCR), prohibits the commitment of additional youth to the Department of Juvenile Justice (DJJ) effective July 1, 2021, and realigns responsibility for those youth to the counties. This legislation further requires that there shall be a Juvenile Justice Realignment Subcommittee of the JJCC, which is statutorily required to develop a separate Plan, "...describing the facilities, programs, placements, services, supervision and reentry strategies that are needed to provide appropriate rehabilitation and supervision services for the youth who are realigned from the state Division of Juvenile Justice to county based custody, care, and supervision or who were otherwise eligible for commitment to the Division of Juvenile Justice prior to its closure."

- 8. Racial and Ethnic Equity and Inclusion (REEI) Data Presentation— Department of Behavioral Wellness (DBW) Forensic Services Manager Shana Burns
  The Probation Department continues to review, analyze and share data regarding REEI and to share data with the public and partner agencies. This has included REEI demographic breakdowns, and presentation of the Relative Rate Index (RRI), which compares youth of different racial groups involved in the juvenile justice system relative to their overall percentage in the population. The RRI also provided an opportunity to review disparities at specific system decision points. In 2021, an invitation was extended to other child-serving agencies to share their data at various system decision points, to create a full picture of REEI data throughout the county, not just within the juvenile justice system, but at earlier points of system involvement in our communities.
