IMPORTANT NOTICE REGARDING PUBLIC PARTICIPATION

Based on guidance from the California Department of Public Health and the California Governor's Stay at Home Executive Order N-33-20 issued on March 19, 2020 to protect the health and well-being of all Californian's and to establish consistency across the state in order to slow the spread of COVID-19, the Juvenile Justice Coordinating Council (JJCC) meeting will not provide in-person participation.

We have established alternative methods of participation in the JJCC meetings, pursuant to the California Governor's Executive Order N-29-20, which states:

- Providing an opportunity to "observe and address" telephonically or otherwise electronically, alone, meets the requirement; and
- Removing the former requirement from Executive Order N-25-20 of having "at least one publicly accessible" location from which the public may observe and offer comment. Executive Order N-29-20 now states expressly, "Such a body need not make available any physical location from which members of the public may observe the meeting and offer public comment."

The following alternative methods of participation are available to the public. If you wish to make a general public comment or to comment on a specific agenda item, the following methods are available:

- Distribution to the Juvenile Justice Coordinating Council - Submit your comment via email prior to 5 p.m. on the Thursday prior to the JJCC meeting. Please submit your comment to medavis@co.santa-barbara.ca.us your comment will be placed into the record and distributed appropriately.

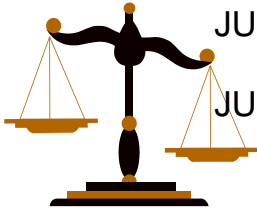

5. **FY 2021-22 Juvenile Justice Realignment Plan (JJRP)** – DCPO Kimberly Shean
Receive input from the Juvenile Justice Realignment Subcommittee of the JJCC, as required by Section 1995 of the California Welfare and Institutions Code, on the development of a secure track program at the Juvenile Justice Center as to strategies programs, placements, services, supervision and reentry strategies needed to provide appropriate rehabilitation and supervision services for the youth who are realigned from the state Division of Juvenile Justice (DJJ) to county based custody, care, and supervision or who were otherwise eligible for commitment to the DJJ prior to its closure.

6. **Racial and Ethnic Equity and Inclusion (REEI) Data Presentation** – Santa Barbara County Education Office (SBCO), Director Rene Wheeler
The Probation Department continues to review, analyze and share data with the public and partner agencies regarding REEI. This has included REEI demographic breakdowns and presentation of the Relative Rate Index (RRI), which compares youth of different racial groups involved in the juvenile justice system relative to their overall percentage in the population. The RRI also provided an opportunity to review disparities at specific system decision points. In 2021, an invitation was extended to other child-serving agencies to share their data at various system decision points to create a full picture of REEI data throughout the county, not just within the juvenile justice system, but at earlier points of system involvement in our communities.
