5. Chief Probation Officer Comments – Chief Heitman

- Chief Heitman announced this would have been Dr. Gleghorn's last meeting and wanted to thank her for her years of services to the JJCC. Dr. Pam Fisher has been appointed as interim Director of BW and will serve as a statutory member of the JJCC and the JJCC Subcommittee.
- The Probation Department's Deputy Chief Probation Officers are rotating assignment to expand their opportunities and experience, Holly Benton now has oversight of the Adult Division, Shawn Small will oversee the Juvenile Division, and Kimberly Shean will take over the Institutions Division.

6. FY 2021-22 Juvenile Justice Realignment Plan (JJRP) – DCPO Holly Benton & DCPO Kimberly Shean

- DCPO Benton shared that the initial JJRP was approved the JJCC and the JJCC Subcommittee on April 2nd, was approved the Board of Supervisor (BOS) on May 18th.
- An updated version of the plan is due to the Office of Youth and Community Restoration by January 1, 2022.
- State level discussions continue regarding how counties utilize regional approaches to ensure availability of specialty treatment beds for this population.
- DCPO Shean advised there will be focus groups, discussions by the JJCC Workgroup, as well as the JJCC Subcommittee to inform our next plan.
- Mona Miyasato advised she sits on a statewide workgroup and requested information about planning meetings to ensure she keeps informed of the work being done by our county.

- 7. Racial and Ethnic Equity and Inclusion (REEI) Data Presentation DSS Deputy Director Amy Krueger & DSS Operations Manager Marianne Reagan
 - Chief Heitman thanked DSS for the work they are doing to track and share their data.
 - A presentation was provided by DSS on Racial Disproportionality and Disparity in child welfare.
 - Mag Nicola asked about allegations that were substantiated and if the majority are for abuse or neglect. Marianne Reagan advised that child welfare uses the penal code definition of substantiation, which is more likely than not that the event occurred, however there are multiple layers to a child welfare investigation.
 - Amy Krueger stated the outcome data represents a relatively low number of youth and can be a family with multiple siblings.
 - Chief Heitman stated the plan is to continue to share REEI data from various stakeholders.

8. Law Enforcement Representative – Chief Tanja Heitman

- A memo was provided and reviewed regarding the request to replace Captain Todd Stoney with Interim Police Chief Bernard Melekian as the representative from the SBPD.

10.Los Prietos Boys Camp (LPBC) Redesign Update – DCPO Kimberly Shean

- A PowerPoint presentation was reviewed with the group regarding the LPBC redesign.
- Victor Vega stated that the transition for youth from custody to the community is important. Established relationships with counselors in custody are important and ensuring a transition to community is beneficial. Shana Burns advised that there are transition team practitioners at Santa Maria Juvenile Hall (SMJH) and LPBC and they stay connected with the youth upon release to assist in linking them with services in the community.
- Paul Boomersbach indicated that there has been challenges with youth transitioning back to public schools. Chief Heitman advised lots of work has been done in this area and she has been very impressed with County Education going the extra mile to ensure that youth returning to the community from LPBC have a warm hand off. Also, youth are making up credits or graduating high school while at LPBC opening up more educational opportunities than in the past. Rene Wheeler advised a school transition plan is individualized for each youth and work is done prior to the youth being released to determine the best educational setting for the youth.
- Dr. Starr advised her team works very closely with BW staff. There was discussion about a transition team and hope that Freedom 4 Youth could be included in these meetings to assist with a more streamlined transition to the community.
