### **Approval of Minutes from June 2, 2017 – All**

- A motion was made by Supervisor Wolf, seconded by CEO Miyasato and approved by those present with the Chief Walsh, Lisa Brown and Superintendent Salcido abstaining, to accept the June 2, 2017, meeting minutes as submitted.

### **Public Comment**

- Britt Stanley is now the north county director for CADA.
- Ed Cué advised that there has been a consolidation of Teen Court with services for Lompoc and Santa Ynez Valley now being provided in Santa Maria. He reviewed the program and funding streams that support Teen Court.

### **Public Comment for Council Members – All**

- Edwin Weaver provided a review of the Mayor's Task Force in Santa Maria.
- On August 21<sup>st</sup> at 5:30 pm at the Boys and Girls Club in Santa Maria First 5 will be having a panel discussion on how intervention for 0-5 can help reduce violence in the long term. Acting Chief Taylor and District Attorney Joyce Dudley will be panel members.
- Lompoc's Car Show will be held on August 19<sup>th</sup>.

### **Chief Probation Officer Comments – Beverly Taylor**

- Chief Taylor welcomed Superintendent of the Santa Barbara County Education Office (SBCEO) Susan Salcido to the JJCC. Superintendent Salcido introduced herself to the group.
- Probation will be before the Board of Supervisor with the resolution updating the JJCC membership, adding a researcher and listing the members by positions.
- The two year term members are due to terminate in the near future and this will be on the agenda in October, with a vote for new members in December to ensure they are selected and in placed by the February 2018 meeting.
- Probation will be updating the Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP). Brian will be doing preliminary work that will be presented at the October meeting. Those agencies interested in participating in data collection were asked to submit contact information via a sign-up sheet.

1. **Reducing Racial and Ethnic Disparity (R.E.D.)** – Wendy Stanley
  - An overview memo was provided and reviewed with the group.
2. **“Results First” Presentation** – Ashleigh Holand, Pew-MacArthur Results First Initiative, Amalia Mejia, California State Association of Counties (CSAC), & Karyn Milligan, Probation Department
  - Ashleigh, Amalia, and Karyn provided an overview of Results First in Santa Barbara County and other counties participating as well as options for utilizing the Result First model for the juvenile population.
  - A Results First convening hosted in Santa Barbara for all California participating counties will be held on October 25<sup>th</sup> and 26<sup>th</sup>. On October 24<sup>th</sup> there will be a workshop to look at how the principles of Results First could be applied to county budgeting and contracting processes, Department’s budget analysis and Chief Fiscal Officers are encouraged to attend.
  - Results First will be on the JJCC agenda in October to discussion if the group would like to utilize the tool with juveniles.
