2. Approval of Minutes from June 1, 2018 – All

• A motion was made by Mag Nicola seconded by Bernard Melekian, to approve the June 1, 2018, meeting minutes as submitted. A vote was taken and minutes were approved.

5. Chief Probation Officer Comments – Tanja Heitman

- On display is a quilt that was made by the youth at Santa Maria Juvenile Hall (SMJH). The
 quilt is being raffled off for the SMJH youth discretionary fund and tickets are available if
 anyone is interested in purchasing. The winner will be drawn on August 21st.
- On November 4th the Los Prietos Boys Camp will have their Fall Festival Fundraiser at the Carriage Museum in Santa Barbara.
- The Los Prietos Business Center will be hosting an open house on September 11th from 3:30 – 5:30 pm.
- The Chief announced that Deputy Chief Probation Officer (DCPO) Holly Benton is now onboard but was not able to attend today's meeting due to travel plans. DCPO Benton has oversight of the Juvenile Division and will be chairing the Juvenile Justice Coordinating Council (JJCC) workgroup.
- The Chief distributed a booklet from the Annie E. Casey Foundation titled *No Place for Kids The Case for Reducing Juvenile Incarceration*.

6. Juvenile Justice Coordinating Council (JJCC) Workgroup – Tanja Heitman

• The Chief reminded the group that at the June JJCC meeting the membership established JJCC Workgroup members. The workgroup membership needed some modification as Holly Benton has since taken the position of DCPO over the Juvenile Division and Sol

- Linver will be replacing Bernard Melekian as Undersheriff on the workgroup and Amy Krueger from Child Welfare Services is being added.
- The SBCEO continues to work to identify a school representative to participate on the workgroup.
- As a reminder due to the Brown Act, there is a limit of no more than six JJCC voting member and their delegates allowed on the workgroup.
- A motion was made by Jill Frandsen and seconded by Saul Serrano to appoint Holly Benton, Amy Kruger, and Sol Linver to the JJCC Workgroup. A vote was taken and all approved.

7. Probation Department Program Update – Brian Swanson

A memo was provided and reviewed with the group.

8. Conflict of Interest/Ethics Training – Tanja Heitman

- The Chief advised the group that there is a legal requirement to have voting members and their delegates to complete conflict of interest/ethics training within the first year of appointment and every two years thereafter.
- Certificates of completion should be forwarded to medavis@co.santa-barbara.ca.us and will ultimately be submitted to the Clerk of the Board for the County's records.

9. Juvenile Institutions Accreditation – Shawn Small

- DCPO Shawn Small informed the group that currently the SMJH and LPBC maintains
 accreditation from the Institute for Medical Quality (IMQ). As a part of medical contracts
 with CFMG in association with adult and juvenile custody facilities, in addition to IMQ
 accreditation, the contract requires CMFG pursue becoming National Commission on
 Correctional Health Care (NCCHC) accredited in both adult and juvenile facilities.
- A gap analysis and action plan was provided and reviewed with the group.
- Dr. Adam advised that a large component for NCCHC accreditation includes increased dental services, largely preventative dental care. There is also a requirement to have medical and mental health training for probation staff, which is currently done but requires greater detailed documentation.
- There is a question if dental services need to be provided for a year prior to being able to request NCCHC accreditation.
- Dr. Lewis advised that Behavioral Wellness will be assessing each youth as they enter SMJH which is a component for NCCHC accreditation. Also related is the provision of substance abuse treatment and the team is reviewing the options for those services. Room confinement or segregation of youth has been a focus and is being reviewed to ensure that all processes are aligned with the accreditation which requires collaboration between Behavioral Wellness and Probation personnel.
- Chief Heitman asked if it there will be additional data collection required that correlates with the NCCHC accreditation. Dr. Lewis advised he has not yet reviewed the data collection requirements for NCCHC.
- Dr. Adam advised that NCCHC requires more data collection involving room segregation and the individual's medical and mental health status.

10. **JJCC October Meeting Date** – Tanja Heitman

• The October meeting was originally scheduled for the October 5th. Chief Heitman will be out of town and not available, as such the meeting will be moved to October 12th.
