- 6. Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) – Holly Benton**
Assembly Bill (AB) 1913, the Schiff-Cardenas Crime Prevention Act of 2000 (Chapter 353), created the Juvenile Justice Crime Prevention Act (JJCPA) program. The JJCPA provides a stable funding source for local juvenile justice programs aimed at curbing crime and delinquency among at-risk youth. Counties are required to complete and annually update a Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) describing objectives and strategies for working with this population. Workgroup members received presentations regarding the content of the 2020-21 CMJJP during the December 2019, January 2020 and February 2020 JJCCW meetings and provided input during those presentations. Members were then invited to provide comments and feedback on the draft version of the plan.
