IMPORTANT NOTICE REGARDING PUBLIC PARTICIPATION

Based on guidance from the California Department of Public Health and the California Governor's Stay at Home Executive Order N-33-20 issued on March 19, 2020 to protect the health and well-being of all Californian's and to establish consistency across the state in order to slow the spread of COVID-19, the Juvenile Justice Coordinating Council Workgroup (JJCCW) meeting will not provide in-person participation.

We have established alternative methods of participation in the JJCCW meetings, pursuant to the California Governor's Executive Order N-29-20, which states:

- Providing an opportunity to "observe and address" telephonically or otherwise electronically, alone, meets the requirement; and
- Removing the former requirement from Executive Order N-25-20 of having "at least one publicly accessible" location from which the public may observe and offer comment. Executive Order N-29-20 now states expressly, "Such a body need not make available any physical location from which members of the public may observe the meeting and offer public comment."

The following alternative methods of participation are available to the public. If you wish to make a general public comment or to comment on a specific agenda item, the following methods are available:

3. Approval of Minutes from February 18, 2020 *Vote Required*

- 4. Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) DCPO Holly Benton Assembly Bill (AB) 1913, the Schiff-Cardenas Crime Prevention Act of 2000 (Chapter 353), created the Juvenile Justice Crime Prevention Act (JJCPA) program. The JJCPA provides a stable funding source for local juvenile justice programs aimed at curbing crime and delinquency among at-risk youth. Counties are required to complete and annually update a CMJJP describing objectives and strategies for working with this population. From December through February, the JJCCW has received a series of presentations on the required elements of the Plan and has had opportunities for discussion and input into the draft.

- 5. Juvenile Justice Realignment DCPO Holly Benton

Senate Bill (SB) 823, passed by the California State Legislature on August 31, 2020 and chaptered September 30, 2020, prohibits the commitment of additional youth to the Department of Juvenile Justice (DJJ) effective July 1, 2021, and realigns responsibility for those youth to the counties. Counties are required to develop a separate plan for these responsibilities, describing the facilities, programs, placements, services, and strategies needed to provide appropriate rehabilitation and supervision services for realigned youth.
