IMPORTANT NOTICE REGARDING PUBLIC PARTICIPATION

Based on guidance from the California Department of Public Health and the California Governor's Stay at Home Executive Order N-33-20 issued on March 19, 2020 to protect the health and well-being of all Californian's and to establish consistency across the state in order to slow the spread of COVID-19, the Juvenile Justice Coordinating Council Workgroup (JJCCW) meeting will not provide in-person participation.

4. Juvenile Justice Realignment - DCPO Kimberly Shean

Senate Bill (SB) 823, chaptered by the California State Legislature on September 30, 2020, prohibits the commitment of additional youth to the DJJ effective July 1, 2021. The first year Juvenile Justice Realignment Plan was submitted to the County Board of Supervisors, on May 18, 2021. The Second Year Juvenile Justice Realignment Plan is due to the Office of Youth and Community Restoration (OYCR) by January 1, 2022.

7. Work Plan for the Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) – DCPO Shawn Small

Assembly Bill (AB) 1913, the Schiff-Cardenas Crime Prevention Act of 2000 (Chapter 353), created the Juvenile Justice Crime Prevention Act (JJCPA) program. The JJCPA provides a stable funding source for local juvenile justice programs aimed at curbing crime and delinquency among at-risk youth. Counties are required to complete and annually update a Comprehensive Multi-Agency Juvenile Justice Plan (CMJJP) describing objectives and strategies for working with this population.
