3. Medication Assisted Treatment Grant – Dr. Cherylynn Lee, Amber Nunes, Lt. Shawn Lammer

Discussion: The Sheriff's Office was awarded a \$25,000 grant to organize a group of stakeholders to address the current opioid epidemic as it relates to persons in custody. The Sheriff's Office has partnered with Behavioral Wellness, Probation, Courts, Cottage Hospital and Marian Hospital to address gaps in the system and build a process for connecting persons to treatment and potentially, establishing a jail-based medication assisted treatment (MAT) program.
