IMPORTANT NOTICE REGARDING PUBLIC PARTICIPATION

The California State Legislature recently passed, and the Governor signed, Assembly Bill (AB) 361, which amends the Government Code to allow Brown Act bodies to continue to meet remotely after September 30, 2021, if there is a proclaimed state of emergency and the State or local officials recommend measures to promote social distancing. Based on the proclaimed state of emergency and the Santa Barbara County Public Health Officer's recommended measures to promote social distancing in order to slow the spread of COVID-19, the Juvenile Justice Coordinating Council (JJCC) and Juvenile Justice Realignment Subcommittee (JJRS) meeting will not provide in person participation.

The following alternative methods of participation are available to the public. If you wish to make a general public comment or to comment on a specific agenda item, the following methods are available:

- Distribution to the JJCC & JJRS - Submit your comment via email prior to 5 p.m. on the Thursday before the JJCC & JJRS meeting. Please submit your comment to medavis@co.santa-barbara.ca.us . Your comment will be placed into the record and distributed appropriately.
- Participation via Zoom or by Telephone;

2. **Reconsider the Circumstances of the COVID-19 State of Emergency** - Chief Heitman
 - a. Reconsider the circumstances of the COVID-19 state of emergency;

3. **2022 Juvenile Justice Realignment Plan (JJRP)** – DCPO Kimberly Shean
Effective July 1, 2021, Senate Bill (SB) 823, passed by the California State Legislature on August 31, 2020 prohibited the commitment of additional youth to the Department of Juvenile Justice (DJJ) and realigned responsibility for those youth to the counties. This legislation further required the formation of a Juvenile Justice Realignment Subcommittee of the JJCC, statutorily required to develop a separate plan, “...describing the facilities, programs, placements, services, supervision and reentry strategies that are needed to provide appropriate rehabilitation and supervision services for the youth who are realigned from the state Division of Juvenile Justice to county based custody, care, and supervision or who were otherwise eligible for commitment to the Division of Juvenile Justice prior to its closure.”

JUVENILE JUSTICE COORDINATING COUNCIL AND SUBCOMMITTEE PRESENT ITS 2022 JUVENILE JUSTICE REALIGNMENT PLAN

(SANTA BARBARA, CALIF.)- On Friday, November 12, 2021, the Juvenile Justice Coordinating Council (JJCC) and the Juvenile Justice Realignment Subcommittee will receive a presentation and vote to approve the 2022 Juvenile Justice Realignment Plan, the plan required by Senate Bill (SB) 823. The meeting will begin at 9:00 a.m. via Zoom.

Effective July 1, 2021, SB823 prohibited the commitment of additional youth to the Department of Juvenile Justice (DJJ) and realigned responsibility for those youth to the counties. The legislation also required a plan, "...describing the facilities, programs, placements, services, supervision and reentry strategies that are needed to provide appropriate rehabilitation at and supervision services for the youth who are realigned from the state Division of Juvenile Justice..."
