# VETERAN'S TREATMENT COURT

## GRADUATE MAKES GOOD

Garrett Bakke is one of Santa Barbara County's first Veteran's Treatment Court (VTC) participants; he entered the Army immediately after completing high school, with the goal of gaining financial support for his college education. While in the Army, he was stationed in Korea, and later in Kuwait. While in Korea, he began abusing alcohol, which led to 17 years of acute alcoholism. Following his return to Santa Maria, he sustained a back injury for which he was prescribed opiates for pain. This ultimately led to the abuse prescription medication in addition to alcohol.

Mr. Bakke's ability to balance his addiction and employment changed when a family member introduced him to methamphetamine. Within days of his first use episode, he was drug tested at work and subsequently lost his job. This downward spiral resulted in the loss of custody of his children, losing his fiancée, and the rapid depletion of his retirement fund. He ultimately suffered a self-described psychotic break due to the combination of malnutrition, sleep deprivation, and untreated physical ailments. Mr. Bakke's mother contacted law enforcement and when the call for service came out, he was described as a "homicidal/suicidal vet."

While peering through the window of a vacant condominium, he was contacted by a sheriff's deputy, who he believes ultimately changed his life. Mr. Bakke was enrolled in VTC, where he was linked with the Veterans Administration (VA). There he received assistance for health issues and connected with fellow vets at 12-Step meetings. Mr. Bakke's case was assigned to Sr. DPO, Bill Roberts (now SPO), who had also been stationed in Korea while serving in the Army, and they developed an instant camaraderie. Mr. Bakke completed VTC in 2013. Within weeks of graduation he obtained a job at Coast Valley Substance Abuse Treatment Center, the same outpatient provider he had attended while in VTC. While here he obtained

his counseling certificate, completed an internship, and facilitated treatment groups.

Today, Mr. Bakke as an AOD (alcohol and other drug) Specialist with the department of Behavioral Wellness, and is the court liaison for the Collaborative Courts. He attends court hearings in Dual Diagnosis and Mental Health Treatment Courts, coming full circle from being a recipient of the Collaborative Court services, to becoming a Counselor. He is also attending Allan Hancock College and has plans to ultimately obtain a Master's degree.

On January 26<sup>th</sup>, Mr. Bakke was reunited with his arresting deputy, Santa Barbara County Sheriff's Office(SBSO) Sergeant Gary Wilberding, and SPO Roberts at the Santa Maria Veterans' Memorial Community Center preceding a Substance Abuse Treatment Court (SATC) Commencement Ceremony. Mr. Bakke's story, and his ongoing relationship with Collaborative Courts, illustrates the power of relationships within VTC.

## ***Tri-Counties Deputy Probation Officer CORE***


## DID YOU KNOW?

- ◆ **Approximately 550 victims are paid each month.**
- ◆ **The average monthly victim payroll is \$55,000.**
- ◆ **In the past year, 302 victims were paid in full. Their final checks totaled \$157,242.**
